# HEATHER PARK DOG OFF-LEASH AREA CONCEPT ROUND 2 ENGAGEMENT

### Context



In 2017, we approved the People, Parks and Dogs Strategy to help deliver carefully designed parks for people with and without dogs. The strategy identified the importance of providing off-leash areas (OLAs) within a 15-minute walk of most residents. An OLA at Heather Park will increase access for dog off-leash activity in two priority neighbourhoods that are currently underserved. Heather Park is large enough that a small, fenced off-leash area could be added with minimal impact to other activity spaces in the park.

In our first round of engagement, we heard from you on topics including park use and proposed amenities. The options provided in the survey were based on guidelines from the People, Parks and Dogs Strategy and an analysis of existing site conditions. The results from the first public engagement have directly informed the design concept in this round of engagement. This round, we are seeking your input on the design concept to help us work toward a refined design that benefits all park users.

Heather Park is a popular destination for laid-back activities like walking, sitting, relaxing, and socializing. As well, daycare groups use the park for outdoor activities and playtime. Many respondents expressed concern about having enough space for the OLA without it interfering too much with these activities.

Top 4 activities enjoyed at the park:



Walk my dog

Walk through park

Sit and relax



77% of dog-owning respondents were interested in having elements for enrichment and agility incorporated into the OLA. Of the agility features proposed, ramps, hurdles, and stepping stones were the 3 most preferred.

### Other Considerations

Caring for OLAs is an on-going task. The heavy concentration of dog activity, animal waste and leaf debris presents maintenance challenges for all types of surfacing. In our first round of engagement, we heard that most respondents preferred wood/cypress chips for surfacing.

### NOTES + THEMES

The OLA would be on the west side of the park, away from the playground, tennis courts, and horse chestnut trees which pose a health risk for dogs. The lawn remains a central feature of the park to accommodate a variety of activities. The OLA will be fenced to make the space safe and comfortable for all park users. See below to learn how feedback from the first round of engagement has shaped the design.

### A Park Use

The size and location of the OLA ensures that much of the lawn remains open for other activities. By fencing the OLA, people and activities outside of this area are less likely to be disturbed by dogs, park users can clearly see the boundaries of the OLA, and dogs can exercise in a safe space.

### Amenities

We have included the most preferred amenities (water, shade, seating, and agility features) in the design of the OLA so that it is a more comfortable and functional space for all.

Agility Features

By including agility features in the design, we've maximized the space by providing different exercise options for dogs. The top three preferred agility features have been included in the design of the OLA and have been located close to one another to keep the rest of the OLA open for running.

Other Considerations

By locating the OLA away from the existing tree canopies along Willow Street, we can reduce the amount of leaf debris in the OLA. Leaf debris would degrade the surface and create an on-going maintenance challenge. We are working closely with our maintenance teams to identify a suitable surface while also keeping the public's preference in mind. To reduce the number and duration of maintenance shutdowns required, choosing a durable surface that our teams can maintain is very important.
