In the summer of 2020, the first issue of the Jericho Lands Policy Planning Program community newsletter was mailed to community members in West Point Grey and Kitsilano, and shared with members of the xwmə0kwəyam (Musqueam), Skwxwú7mesh (Squamish), and sålílwata? (Tsleil-Waututh) Nations. The newsletter provided an update on the project and asked for feedback on draft Guiding Principles. This newsletter provides update on work completed in the last year and seeks your feedback on two conceptual site plans.



Project Update

Over the past year we have completed Phase 2 of the Jericho Lands planning process. Since July 2020, we have shared the Site Analysis Panels and themed Discussion Guides, gathered feedback through online surveys, developed a series of Site Planning Emerging Ideas, and co-hosted Virtual Design Workshops. We refined the draft Guiding Principles and Emerging Ideas based on public feedback gathered at events and online. In June 2021, Vancouver City Council endorsed the draft Guiding Principles and Emerging Ideas which establish a foundation for the development of the conceptual site plans.

Upcoming Engagement Opportunities

City staff have been working collaboratively with the landowners' design team to develop a number of conceptual site plan options. As we move into Phase 3 of the planning process, we would like your input on these site concepts.

Between Monday, October 18 and Wednesday, November 10, we will be hosting engagement opportunities for you to share your feedback. The policy statement is being developed at the request of the landowners, a joint venture partnership between the Musqueam Indian Band, Squamish Nation, and Tsleil-Waututh Nation ("MST") Partnership and Canada Lands Company ("CLC").

The Jericho Lands Policy Statement is being created in consultation with the community, landowners, and other stakeholders before being presented to City Council for consideration.

The Jericho Lands planning program was launched in March 2019. It is a comprehensive planning process which will lead to the creation of a policy statement to guide future development of the site.

A policy statement is a guiding document that establishes principles, objectives, and policies relating to a range of topics. These include:

- Reconciliation;
- Mix of Uses;
- Density, Building Types and Heights; •
- Mobility;
- Sustainability and Infrastructure;
- Ecology, Parks and Open Space;
- Community Amenities; and •
- **Development Phasing** •

Once adopted by Council, the Jericho Lands Policy Statement will inform future rezoning and redevelopment of the site.

Jericho Lands Planning Process Update

Since launching the planning program in 2019, the City has co-hosted a variety of in-person and virtual public engagement events. At these events we have connected with thousands of community members, members of the xwməθkwəýəm (Musqueam), (Squamish), and Skwxwú7mesh səlílwəta? (Tsleil-Waututh) Nations, stakeholder groups, and individuals from across the city.

Phase 1 Engagement Activities

Phase 1 of the Jericho Lands planning program was a listening phase. It was an opportunity to gather information, listen to your ideas and aspirations, and learn about key issues and opportunities for the future ?ay 'almaxw / y 'almexw / Jericho Lands.

information 2019, Throughout was gathered through a variety of activities including: open houses, asset mapping, a survey, a series of speaker events, walking tours, pop-up information booths, artist workshops, and community presentations. The feedback received during Phase 1 informed the development of the draft Guiding Principles.

Phase 2 Engagement Activities

Phase 2 of the planning program took place between July 2020 and June 2021. It was an opportunity to share information we had learned during earlier engagement and seek feedback on initial site analysis, the draft Guiding Principles, and Emerging Site Planning Ideas. A brief summary of Phase 2 activities is provided below.

Summer 2020 Community Newsletter

In July 2020, we distributed almost 12,000 copies of the first issue of the community newsletter. The newsletter was intended as a project update and included background information on the planning program, an overview of the engagement activities in Phase 1, a high-level summary of what we had heard to date, a copy of the draft Guiding Principles, an introduction to the landowners' design team and the cultural liaisons, and project next steps.







Draft Guiding Principles & Survey

The draft Guiding Principles were first introduced in the summer 2020 community newsletter. These principles were based on feedback received in Phase 1 of the planning program, City objectives and policies, stakeholder priorities, and the landowners' aspirations. A link to an online survey was provided in the newsletter and the survey was open for responses from July 9 to September 25, 2020.

The draft Guiding Principles were updated to reflect the feedback we received via the survey and were later endorsed by Council in June 2021.

Site Analysis Panels & Survey

Through 2020, the landowners' design team worked with City staff to develop an understanding of ?əy'alməxw/y'álmexw/ the Jericho Lands and its surroundings. A summary of this understanding was presented online via a series of Site Analysis Panels (previously referred to as 'Topic Explorations'). This analysis provided a high-level overview of the Jericho Lands as they are today, and was intended to serve as a foundation for more detailed policy development and design work to come.

Between February 17 and March 12, 2021, City staff hosted an online survey. The comments received provided further insight and were used to expand the collective understanding of the site.

Discussion Guides, Emerging Ideas & Survey

Between March 29 and April 25, 2021, we asked for feedback on the Emerging Ideas via four themed online surveys. Each survey focused on the Emerging Ideas relating to one of the four topic areas above. The Emerging Ideas were updated to reflect the feedback we received via the online survey and at the Virtual Design Workshops, and were later endorsed by Council in June, 2021. The Emerging Ideas have since been used to develop the conceptual site plan options which are the focus of upcoming engagement.

Virtual Design Workshops

In April 2021, City staff co-hosted a series of eight themed Virtual Design Workshops with the landowners and their design team. The workshops were an opportunity for the public to learn about the Emerging Ideas outlined in the Discussion Guides, discuss with other attendees, and share thoughts and ideas with staff and the design team. In addition, Kick-Off and Wrap Up events bookended the eight workshops. The Kick-Off event introduced the workshops and the broader planning process, while the Wrap-Up event provided an opportunity for a high-level overview and report out of the week's findings.

The presentations and report out sessions of each workshop were recorded, as well as the entire Kick-Off and Wrap-Up events, and can be found on the project website. The feedback gathered at the Virtual Design Workshops have been included in the Phase 2 Public Engagement Summary.



In March 2021, City staff shared a series of five Discussion Guides (including a Primer document), via our project web page. Each Discussion Guide focused on a specific topic area and identified a series of Emerging Ideas relating to those topics. The Discussion Guides presented the following themes:

• Natural Systems and Open Space Connections and Mobility Inclusive Neighbourhood • Sustainability and Resilience







Report to Council

On June 23, 2021, Vancouver City Council endorsed the Jericho Lands draft Guiding Principles and Emerging Ideas at the Standing Committee on Policy and Strategic Priorities. The draft Guiding Principles and Emerging Ideas establish a foundation for site planning as we move into Phase 3 of the planning process, and the development of conceptual site plan options.

Phase 2 Public Engagement Summary

A detailed summary of Phase 2 has been compiled, outlining the engagement activities and key feedback gathered between July 2020 and June 2021. The feedback from Phase 2 of the process has been used to refine the draft Guiding Principles, develop the Emerging Ideas, and inform the conceptual site plan options. Initially shared in summer 2021, the Phase 2 summary can be found on the City's project web page at shapeyourcity.ca/jericho-lands.



'Embedding Indigenous Knowledge and Values' means that ?əy 'alməx^w / y 'álmexw / the Jericho Lands will tangibly express x^wməθk^wəỷəm (Musqueam), Skwxwú7mesh (Squamish), and səlilwətał (Tsleil-Waututh) culture, knowledge, and identity in the planning and design of all aspects of the site. Embedding Indigenous Knoweldge and Values defines the fundamental approach to the project.

SITE PLANNING **EMERGING IDEAS**

We have developed a series of Site Planning Emerging Ideas based on key learnings from Phase 1 and 2 of the Jericho Lands planning process. These Emerging Ideas look to the future of what ?əy 'alməx^w / y 'álmexw / Jericho Lands can become, while Embedding Indigenous Knowledge and Values to showcase the historic and cultural importance of these lands to the x^wməθk^wəỷəm (Musqueam), Skwxwú7mesh (Squamish), and səlilwətał (Tsleil-Waututh) peoples. They establish the key directions in the development of conceptual site plan options for the lands.



CONCEPTUAL SITE PLAN OPTIONS

The landowners' design team has worked to develop a baseline understanding of the site through technical reviews, engagement with the cultural liaisons, review of Phase 1 and Phase 2 materials, and analysis of City policies. Using this information, they have worked collaboratively with City staff to develop two conceptual site plan options. Below is a description of the cultural signifiance and key defining elements of the conceptual site plan options.

aqes / sp'akw'us / Eagle: A bird on the wing soars from ocean to ridge

This concept emerges from the spiritually important eagle, a symbol of accomplishment, courage and wisdom for the x^wməθk^wəy̓əm (Musqueam), Sk̠wx̠wú7mesh (Squamish), and sôlílwəta? (Tseil-Waututh) cultures. Eagle soars through the sky on a journey, seeing the big picture and the small detail. Eagle represents xmmə0kməyəm (Musqueam), Skwxwú7mesh (Squamish) and sảlílwəta? (Tsleil-Waututh) ancestors who have passed before, a spiritual messenger that guides from the past to the future, looking over generations to come.

In the 'Eagle' concept, an elongated diagonal non-vehicular greenway stretches through the new community creating a series of connected open spaces from the lower northeast entrance to the southwest ridge top gathering space. The diagonal creates a flight along a 'waterway' wing to a central park of natural woodlands and active public amenities and travels up to a proposed mixed-use urban transit plaza accentuated by three iconic "sentinel" buildings representing the MST partnership, and finally ascends to the top of the ridge providing dramatic views to downtown and the mountains.



4-en / tahim tl'a uxwmixw-chet / Weave: Connecting fine-grain networks and gathering spaces into a strong community fabric

In the 'Weave' concept, a fine-grained mobility and social space network winds around a central east-west pedestrian/cycling corridor. The central spine knits together three distinct neighbourhood hearts and is bisected by a north-south park, forest and open space patch. This concept proposes a hub of transit, community/cultural amenities, and retails spaces; and is anchored by three iconic "sentinel" buildings representing the MST partnership. Streets and pathways connect the new community with surrounding neighbourhoods through welcoming entries and permeable intersections, and link the city to the ocean. Stormwater management is woven through the community along pathways, intertwining infrastructure and place-making.

This concept emerges from weaving, an activity that is intrinsic to x^wməθk^wəÿəm (Musqueam), Skwxwú7mesh (Squamish), and sə́lílwəta귀 (Tseil-Waututh) cultures. Weaving interlaces stories and teachings into rich patterns that tell stories of who they are. Weaving uses materials that come from the land and that remind the x^wməθk^wəỷəm (Musqueam), Skwxwú7mesh (Squamish), and səlílwətaə (Tseil-Waututh) people of their close connection to the natural world. Weaving winds together old worlds and new into a unique fabric that carries important teachings for living today and that will last for many tomorrows.
